- Auto larceny continues to be the most frequently-reported crime in Zone 2. Auto larceny is a property crime, so sentences are not nearly as severe as a robbery, which is prosecuted as a violent crime. Therefore, most arrested for auto larceny are released on bond. APD recommends that residents avoid/mitigate auto larceny risk by not leaving valuables in parked vehicles. Approximately 70 percent of auto larceny victims are NOT residents of the City.
- For July 4 celebration, APD resources will be managed and shifted as necessary between Lenox area and Centennial Park.

Tiffany Harlow reported on a significant disposition of a series of three related crimes committed in Zone 2 back in April. The first involved a victim picked up in Zone 2, driven around for approx. 21 hours, and left in another county. The second was an aggravated sexual assault; and the third a robbery. One of five suspects was tried, convicted, and sentenced to life plus 70 years. Another, was sentenced to 30 years imprisonment under a plea bargain. The other three defendants are still negotiating plea bargains.

- The new MARTA pedestrian bridge in Tower Place area is now open. There will be 24-hour police surveillance with at least one officer dedicated to patrolling the bridge area at all times.
- PATH400 Phase 1 is underway and scheduled for completion by end of calendar year 2014. Lenox Road is being modified in the "Loop" area between Tower Place and GA400 by narrowing each lane by approximately one foot to create space where the Path intersects Lenox Road
- Regarding Peachtree Transformation, Phase III and IV, the planned public "open house" has been postponed to allow more analysis by GDOT. The open house will be announced later but will not occur until late August or September.

- The Zoning Committee did not meet in June because each of the two pending applications was deferred at the request of the applicant.
- At its next regular meeting in July, the Zoning Committee will hear an appeal of administrative issuance of two building permits for 136 West Wesley Road. Applicant is the Archdiocese of Atlanta, and the property was formerly the residence of the Archbishop and is now being remodeled to serve as a residence for up to six priests assigned to the Cathedral of Christ the King. Appeals of administrative decisions are not voted upon in the same manner as pending applications, but the Zoning Committee is able to make comments and/or recommendations to the BZA.
- Fuqua Development LLC and/or Jeff Fuqua (formerly of The Sembler Company) plans to present another proposal for the site with frontage on Piedmont Road between Lindbergh Drive and Morosgo Drive, directly across from the Lindbergh MARTA station, within Special Public Interest District 15 (SPI-15). This is the site of the Walmart proposal back in 2012.
