### **Proposed Fee Increase**

14-O-1240 An Ordinance by City Utilities Committee amending Chapter 138, Article IV, Sections 138-76 and 138-96, and Appendix B, of the City of Atlanta Code of Ordinances to increase residential sidewalk installation fees when the City of Atlanta directly provides the installation services; and for other purposes.

14-O-1241 An Ordinance by the City Utilities Committee amending Chapter 130, ("Solid Waste Management"), Article II, ("Municipal Collection and Disposal System"). Division 1, ("Generally") at Section 130-44 of the City of Atlanta Code of Ordinances so as to
