Captain Lee, reporting

- The leading reported crimes in Zone 2 are (1) shoplifting; (2) auto larcenies; and (3) residential and commercial burglaries. Many auto larcenies involve use of a rented car to move around and break into parked cars.
- There was an arrest made in past month in connection with an attempted rape on Highland Drive in Peachtree Park.

- During ice storms staff was increased to handle trees down and power outages. Station 26 at Moores Mill Road housed approximately 30 citizens who had been stranded on roads, etc.
- Five new firefighters have been added
- Stations 21, 26 and 29 all responded to the December 8 fire at Peachtree Bikes on Peachtree Road. The cause has not been officially determined. Peachtree Bikes will relocate to 2955 Peachtree Road.

- "Step-in" temporary sign nuisance is not within jurisdiction of Code Enforcement. Where located within the right of way (ROW), enforcement is the responsibility of the Dept. of Public Works, and where located on sidewalks, enforcement is the responsibility of the Zoning Department and/or Bureau of Planning.
- A total of 23 Code enforcement complaints were received in past month, including 3 hazardous materials matters. In 10 of these 23 matters the investigation revealed no violation. Another four were brought into voluntary compliance. Two others are being researched further, and citations have been issued in connection with another two.

Proposed Ordinance 14-O-1022 would amend the City Code to create a new Article in Chapter 46 (civic and cultural affairs) to govern works of art on private property viewable by the public. The ordinance establishes an application procedure administered by the Bureau of Cultural Affairs. Certifications are required (1) from the bureau of traffic and transportation that the proposal will not constitute a traffic hazard or hazard to pedestrians; (2) from the urban design commission that the work does not contain and is not primarily intended to convey a commercial message; and (3) from the bureau of cultural affairs that the work is not inconsistent with the City's public art program. Following such certifications the application is to be heard by the affected NPU and, after the NPU meeting at which the application is presented, the NPU shall have fifteen (15) days to forward its recommendation to the Office of Cultural Affairs. If no NPU recommendation is received by the deadline, a finding of no recommendation shall be recorded on the Application.

Applicant seeks a variance from the zoning regulations to reduce the south side yard setback from existing 5' (5' setback was granted from another variance) to 3' and to reduce the north side yard setback from 10' (required) to 7'5" for a second story addition. Applicant seeks a variance from the zoning regulations to reduce the front yard setback from 50' (required) to 47.5 feet, to reduce the west side yard setback from 10 feet (required) to 4.5 feet and to reduce the east side yard setback from 10 feet (required) to 9 feet to add a new garage with a second floor living space (front side) and a one story covered porch to the back.
