Major Hobbs reported that reported crime in Zone 2 is down seven percent overall compared to last year. Significant arrests over past month include one suspect linked to over 200 theft by taking crimes in the City and also in Cobb County and other neighboring areas. Complex case squads are involved in such multiple-jurisdiction investigations. Zone traffic unit is making approximately 1200 traffic stops per month, mostly from 6:00 am until midnight, but as additional officers are hired APD plans are to increase to 24-hour coverage.
