3. PRESENTATIONS / ANNOUNCEMENTS:

a. Atlanta Public Schools (APS)

APS was on the agenda but did not appear/report.

b. Alcohol Technical Advisory Group (ATAG)

Richard Rauh (NPU-B APAB delegate) and Rashid Mohammed (Public Safety Chair for APAB and Chair, NPU-M) presented highlights of the ATAG II Alcohol Code draft recommendations. ATAG's final vote on its recommendations for amendments to alcohol ordinances will take place

at its next meeting this Wednesday, May 8 at 6:30 p.m. in Council Meeting Room 2. A summary of the proposed changes was distributed. Mr. Mohammed highlighted three major areas:

- grandfathering provisions
- future role of NPUs in process (historically NPU denial recommendations have had little impact downtown at LRB)
- "hybrid establishments" (restaurant by day but acting as nightclubs after hours, not subject to noise restriction because regulated as a restaurant, not a club): There will be a recommendation to create a new hybrid license to ensure proper regulation and accountability.

c. Draft Ordinance 13-O-0637 (proposed amendments to municipal alcohol code) At the April 2013 NPU-B meeting, and with reference to the Selig space at intersection of Peachtree and Piedmont Roads formerly occupied by The Container Store, Scott Selig and his counsel, Kevin Leff, reported regarding a conceptual proposal to permit sales of wine and beer (but no distilled spirits) in certain areas along the Peachtree Street and Peachtree Road corridor, which would currently be prohibited by the distance requirements from a residential use. No written draft was presented, cited or discussed.

At some time between at April NPU-B meeting and this May NPU-B meeting, draft Ordinance 13-O-0637 was introduced to City Counsel. The ordinance would amend Part II, Section 10-88.1(b)(1), City of Atlanta Code of Ordinances, which currently provides that no package store may be located within 600 feet of a structure in residential use, so as to add the following proviso:

Provided however, that a package store selling malt beverages and/or wine but not distilled spirits may be located within 600 feet of structures in residential use if the package store is located within a shopping center that contains a minimum of 75,000 square feet of gross leasable area and which has an address on Peachtree Road or Peachtree Street and which is located north of Interstate I-85.

NPU-B Action: By vote of of 24-0-2 a motion was passed that the Chair shall address a letter to councilperson Howard Shook stating that the the NPU-B is opposed to draft ordinance 13-O-0637.

Further NPU-B Action: It was agreed without vote that the Chair would appoint an ad hoc committee of the NPU-B to explore various possibilities and make a recommendation to the full NPU-B regarding whether and to what extent the NPU-B might support relaxing the distance requirements from a residential use.
