Festival Applications (no NPU vote):

Randall Fox of the Atlanta Foundation for Public Spaces (AFFPS) spoke regarding the 2015 Chastain Park Arts Festival which is scheduled to be held on Mothers Day weekend, May 9-10 (Saturday from 10:00am to 6:00pm; Sunday from 11:00am until 6:00pm). Mr. Fox reported that these plans involve a street closure application for Park Drive (located just North West Wieuca), and an alternate plan to close West Wieuca Road in the event of a concurrent event at the Chastain Amphitheater. Some NPU-B members expressed concern regarding traffic and parking issues associated with holding the event at that location during Mothers Day weekend or any other weekend during the NYO Spring baseball and softball seasons. Essentially the concern is that, during that time, the area is at or beyond capacity as a result of the NYO baseball and softball programs (which have been running at Chastain Park for decades) and heavy seasonal use of the golf course and tennis center at Chastain Park, which have the area at or beyond parking capacity and encumbered by heavy weekend traffic moving in and out of the area (as opposed to merely passing through the area). Mr. Fox stated that the application had been filed months ago and that AFFPS will go forward with the event as planned.
