Councilperson Shook has introduced legislation which would require set-asides for a future infrastructure repair budget. The current City budget does not include infrastructure repair, the true cost of which is estimated at 3-5 percent of the current municipal budget, hence the proposal for a bond issue to raise capital for infrastructure repairs.
