#### 5. PLANNER'S REPORT

Carter Coleman attended on behalf of Jessica. He presented the Quick Fixes. None of the codes and ordinances are changing but some of the language is being clarified.

There was a question about including the pictures and definitions within the zoning code. Andrea commented that the discussion was form based code and that will be done at a later date. This is not the zoning rewrite which is 3 to 4 years from now.

There was a question regarding sidewalk requirements. The quick fixes shows that the City can make adjustments to sidewalks. There is a pretty elaborate process for sidewalk variances currently. Does this waive the variance process so that the community can work with Planning more effectively. Carter confirmed that the intent was to improve this process.

There was a comment that if sidewalks are not required, then the developer should be asked to donate to a sidewalk fund for sidewalks to be built in other locations.

MR/RG Single and Two-Family Minimum Lot Sizes, there were concerns about the impact of this topic and the impacts on stormwater and other issues of allowing these lot subdivisions. There were concerns about existing infrastructure and maybe this needs a second look.

There were questions about PODS and whether the excessive length of time was a code enforcement issue.

There was a question regarding a house that has not been completed and there is no room for a driveway. Is this a code enforcement issue? It is likely a code enforcement issue.

NPU-B action: A motion to recommendation approval of the "Quick Fix" ordinance with the following two revisions; (1) creation of a in-lieu parking fund and (2) removal of Topic 7 for further study/ evaluation passed by vote of 22-0-1.
