Tony Peters - here and reporting:

Plan to fix \$900K of sidewalks; bids are now back. In July they will award bid and plan to be done in Oct

The Expansion of the CID to the west village happened 3 years ago – as such, road work that was promised as a result of this expansion will be starting in September. Developers put in \$\$ per the SPI requirements, with the CID coming in behind to fill the gaps in projects. CID is now coming back in and will resurface roads in this area after developer work is complete.

Peachtree Phase 3 Maple to Shadowlawn update – they are now "truly" at end of construction – only 4 parcels left to purchase – Brown Jewelry, CVS, Bridal and one other – all owned by same owner - once acquired, work will get started

Design: widening Piedmont to Peachtree on Kroger side -5 lanes to 7 lanes - also putting in a 10-12' multi-use path. Work starts late 2020/early 2021

Design: Roundabout re-design now going on – expect a 10 month process to complete. Plan to start in 2020 subject to Right-of-Way acquisitions

Lenox Road between E Paces and Peachtree improvement project - floating a new "boardwalk concept". Now has 2.5M in federal funds committed with an expected 15-month design process

Finishing seasonal color on Peachtree

Lenox/400 exit - GDOT did the temporary re-line work after the paving that was recently done

GDOT: Wieuca – Lenox – Peachtree going to be repaved in 2020 (CID partnering w/the City)

Turn lane at Stratford and Peachtree at new Related Group building is being finalized

C. ZONING COMMITTEE

V-19-118: 500 Cobblestone Drive NE

APPROVED (8-0 at committee)

Applicant seeks a special exception from the zoning regulation to allow active recreation in a yard adjacent to the street for the construction of an in-ground swimming pool.

V-19-123: 686 Greenview Drive NE

APPROVED (8-0 at committee)

Applicant seeks a variance from the zoning regulation to reduce the west side yard setback from 7 feet to 3 feet.

NPU-B action: A motion to approve the consent agenda passed by vote of 20-0-0.

V-19-126: 464 Pine Tree Drive NE (AKA 464 Pine Street Drive NE) Applicant seeks to appeal an Administrative Officer decision.

This project was discussed at the May 7th NPU meeting and the vote was 23-0-0 to deny the variance with prejudice. The denial noted that the City had incorrectly classified the lot. This lot is an irregular lot and therefore the historic pattern of development along Pine Tree Drive should be respected. The Garden Hills neighbors are appealing the decision by the City to allow the reduction in the front yard setback from 35 feet to 17.5 feet, based on the incorrect property classification.

The NPU still supports this decision to deny and hopes that the BZA carefully evaluates the information at the August 1st meeting date and corrects the lot classification.

Nancy commented the Board was strongly against this; Jessica recommended that we send our comments to Raquel

NPU-B action: A motion to deny V-19-126 passed by vote of 18-1-1 at the Zoning Committee Meeting. (NO ACTUAL VOTE ON 7/2)

SD-19-17: 2829 W Roxboro Road

Applicant seeks to subdivide the property into 2 lots.

The applicant presented a partial demolition and "staged" or "step-wise" construction at the June 4th meeting. Based on feedback from the NPU, the applicant has revised the site plan and plans to subdivide only into 2 lots.

Conditions to the subdivision:

- 1. Two lots are fully conforming R-3 lots and the project complies fully with the City's tree ordinance at the time of permitting
- 2. No variances to the front, side, or rear setbacks are issued with the exception for maintaining the existing home which encroaches in the front setback.
- 3. All houses face W Roxboro Road and respect the historic development pattern of the neighborhood
- 4. No new retaining walls greater than 8 feet to be constructed anywhere on the property
- 5. The property is treated as a "common development" for stormwater management purposes. Stormwater maintenance agreements and indemnification agreements must be filed with the City for all stormwater management facilities on any of the existing or future parcels.
