CONDITIONS: Carl Westmoreland appeared to discuss conditions and stated the agreement was negotiated with Peachtree Hills; Kyle Cunnion and Greg Holliday appeared from Peachtree Hills to reiterate Mr. Westmoreland's statement; David Mitchell from Atlanta Preservation Center appeared to ensure inclusion of APC as oversight only as an amendment to ensure the conditions are met properly and ensures the building's integrity.

A separate issue was raised by Nancy to discuss NPU processes and how we can streamline so all parties are brought together earlier and more collaboratively.
