1. OPENING REMARKS / CHAIRPERSON'S COMMENTS

Dr. Bliwise welcomed everyone. No media present.

4. REPORTS FROM CITY DEPARTMENTAL REPRESENTATIVES, ELECTED OFFICIALS, AND OTHERS IN AUDIENCE

Atlanta Police Department (APD)

Major Senzer reports that the incident at Ovation, in NPU-A, was ruled a suicide not a homicide. There was some misleading press surrounding the incident. Additionally, the homicide outside the club on Roswell over the weekend is under investigation and happened after a conflict on the



street escalated. It happened in the presence of three APD officers and one Federal Marshall who were on-scene to control the fight; they are seeing these incidents turn violent quickly. That area is a focus for late-night patrols.

Outside of these incidents, crime in Zone 2 is low overall (-26% in Part 1). Last week, there were 16 car break-ins, which is lowest it has been in a while. Major Senzer attributes the crime reduction to some crews being held in jail under Georgia Gang Statutes, as well as boosted patrolling. They hope to continue the low numbers through the summer.

The new Village precinct is on target to open in May. As the Academy graduates are assigned, APD will continue to add new officers to this precinct.

Waterboy incidents are down 83%; they continue to make arrests as they are able, as well as apply connect and deter strategies. They will continue to focus on this area.

Connect Atlanta will allow homes and businesses to connect camera surveillance to APD. This is the introduction to the public of the city-wide program to integrate privately supported cameras into the APD system. APD would like us to inform our residential and business constituents about the program and encourage everyone to join.

A board member asked about a pedestrian hit at Valley and Habersham in November; she wondered if there is a possibility to have patrol posted at the intersection to alert drivers and bring awareness to the crosswalk. Major Senzer suggested also petitioning A-DOT for a radar signal as well.

3200 Lenox – As of today, case number has decreased to 16. Six citations have been initiated; three have been served and three more will be served. He expects that number to increase. Officer Grayer is working closely with the property manager and residents.

2479 Peachtree – Property manager has what they need now to update the sidewalk; Officer Grayer will stay in touch with the property.

A board member asked about high case levels, like at 3200 Lenox, and wondered if there was a threshold or a different process that might happen when one location has so many incidents; Officer Grayer mentioned the department issues a detail, which he will ask about. The board member asked for the property manager's information to help assist in tandem with Councilman Shook. Ms. Carey mentioned there was an escalation process and increased penalties for properties with high case levels and repeat offenses.

A board member asked about an update on 2512 Rivers; Officer Grayer will follow-up again.

A board member asked about 127 West Paces Ferry; Officer Grayer wrote a citation for the property previously and will check on it again. The board member also mentioned the pedestrian walkway is overgrown and dangerous.

Dr. Bliwise raised the issue of donations to APD and AFRD; with the transition from Ben Howard to Kim Shorter as treasurer, we did not make our annual \$500 donations to those organizations. Jefferson McConkey suggested we consider additional \$500 donation for DUI Training, as well as future events that are community-oriented and benefit public works. Dr. Bliwise will consult with Leah LaRue about engaging other NPUs and Ms. Shorter will develop an annual budget for evaluation.

NPU-B action: A motion by Jefferson McConkey to approve donation to DUI Training passed by 19-0-0. A motion by Jefferson McConkey to approve donations to 18-0-1.

Sherry Williams, organizer for Campbellton Rd-Greenbriar neighbors to revoke the building permit on behalf of NPU-R, thanked NPU-B for the letter of support regarding the service station; the service station was debated hotly and deferred before being approved. NPU-R filed an appeal with Superior Court; the case was filed last week and everyone was served. To cover attorney costs, including filing fees and serving fees, they need another \$5,800 and are soliciting donations.
