Officer Francis, from the SWEET team, reminded everyone that bulk pick-ups are intended for larger items, like furniture or appliances, as well as yard waste with more than 20 bags or chopped up trunk pieces. Bulk pick-up piles may not be larger than 8 cubic yards. Refrigerators must have the doors and freon removed. All bulk pick-ups must be scheduled in advance; Officer Francis noted they are running around 4 weeks out to be scheduled. Items may not be placed at the curb until the evening before the scheduled pick-up.

Contracts for contractors assisting the city with yard waste pick-up have ended. The city will resume their bi-weekly schedule for yard waste pick-up; check DPW's website for the pick-up schedule.

A board member asked about proposed rate changes; Officer Francis is unable to provide any feedback but will request a representative who can for the next meeting.

V-22-120 / 4660 Club Circle / Approved with conditions

Applicant seeks a Special Exception to allow a 6ft high opaque wooden wall "privacy fence" within the half-depth front yard and to allow active recreation (swimming pool) in a yard adjacent to a street. The committee voted 4-0-0 to approve, conditioned on the site plan and withdrawing the request for a solid fence and installing a fence fully compliant with city code.

V-22-115 Amended / 3995 North Ivy Road / Approved with conditions

Applicant seeks a variance to increase the lot coverage from 40% to 46.47% and a Special Exception to allow active recreation (swimming pool) in a yard adjacent to a street. The committee voted 5-0-0 to approve, conditioned on the site plan and the homeowner installing stormwater to capture either new or existing impervious area even though the project is below the threshold. Part of the rationale for approving the lot coverage increase was that the lot was smaller than the minimum but more importantly, changes to existing impervious areas would compromise the safety of a family member who has physical challenges.

V-22-107 / 3512 Old Ivy Lane / Approved with conditions

Applicant seeks a Special Exception to allow active recreation (swimming pool) in a yard adjacent to a street. The committee voted 4-0-0 to approved, conditioned on the site plan.

All three applicants were reminded that the overflow must be more than 10 feet from the property line and that concentrated flows cannot cause damage downstream.

V-22-090 / 3243 Andrews Court / Deferred

Applicant seeks a variance to reduce the rear-yard setback from 20ft to 3.49ft for the construction of a gazebo.

Applicant seeks a variance to reduce the front-yard setback from 50ft to 11.7ft and to increase the size of an accessory structure from 30% to 50.5% for the construction of a detached garage.

V-22-124 / 97 Carlton Drive / Deferred

Applicant seeks a Special Exception to allow a 6ft high opaque wooden wall "privacy fence" within the half-depth front yard and to allow active recreation (swimming pool) in a yard adjacent to a street.

Dr. Bliwise distributed the proposed 2023 bylaws via email to the board on August 23 at 4:33 PM and posted on NPU-B's website for public review. Several residents, all from Garden Hills and Peachtree Hills, expressed concern for lack of transparency and equity with their neighborhood associations for both non-dues paying residents and multifamily home residents.
