Major Mitchell noted crime is up 50% in stolen vehicles citywide. Zone 2 is down 9%, with the majority of crimes as shoplifting from organized theft rings; with motor vehicle thefts, most are leaving their cars running at the gas station, ATMs, etc., and on the borders of Zones 1 and 5. APD is focused on street racers, water boys and quality of life issues. Calls have increased in the



last couple of weeks for the water boys – continue to call 911 (or non-emergency line if preferred) so they have a record and can dispatch accordingly. APD has been working with GSP to focus on street racers as they travel from Gwinnett and Cobb to cut them off. Follow APD on social media to see big arrests.

A board member asked about an attempted rape at Fogo de Chao; Major Mitchell advised the case was being led by the state.

A community member asked about a tree being removed illegally over the weekend; Major Mitchell asked her to send more information for follow-up.

Ms. Wilson reminds everyone to call 3-1-1 for everything from potholes to traffic lights to mental health issues. She was pleased to report PAD calls have increased and more people are being helped. Sign up for City of Atlanta emergency alerts by texting NOTIFYATL to 888777.

A board member asked about availability at night and on the weekends; Ms. Wilson noted that City Council approved moving 311 to 24 hours and the vote is moving through the Mayor's office for review and approval.

A board member asked about chronic mental health issues near her neighborhood – she learned county services can send out social workers, etc. but wasn't sure when to call county versus when to call 311. Ms. Wilson stated if there is an immediate issue to call 911, but call 311 with other issues and they will dispatch the appropriate party (the county, Grady, etc.).

LeTisha McCall from PAD reiterated what Ms. Wilson noted – call 311 to report any quality-of-life issues and PAD will take immediate action to get them help as needed. Any immediate concerns regarding life or death, call 911.

V-23-30 / 2430 Shenandoah Avenue / Approved 9-0-0 conditioned on site plan Applicant seeks a variance to enlarge existing non-conforming structure by increasing the ceiling height from 10 feet 3 inches to 12 feet in the rear yard.

V-23-35 / 2405 Shenandoah Avenue / Approved 9-0-0 conditioned on site plan Applicant seeks a variance to reduce the front yard setback from 35 feet to 18 feet for construction of a second-level addition for an existing single-family dwelling.

NPU-B action: A motion by Bill Murray to approve the consent agenda passed by a vote of 15-0-0.

V-23-39 / 183 Lindbergh Drive / Approved 9-0-0 conditioned on site plan Applicant seeks a variance to 1) reduce the required rear setback from 15 feet to 7 feet 5 inches for the proposed gym and 2) enlarge existing non-conforming carport by increasing the square footage from approximately 314 square feet to approximately 420 feet of the carport located in the rear and side setbacks.

Angelita Zouiten represented the homeowners explaining the situation with the trees and why areas are outside of the setback. David Yoakley Mitchell discussed the historical impact of the home plans not including any recognition of the historical significance; Ms. Zouiten will meet with Mr. Mitchell to incorporate language regarding historical inclusion. Laura Dobson noted trees are often presented being saved but are removed after BZA approval.

NPU-B action: A motion by Bill Murray to approve 183 Lindbergh Drive with conditions passed by a vote of 16-0-1.

Applicant seeks a Special Exception to allow a 6.5ft opaque fence in the required half-depth front yard and front yard setback for a single-family dwelling.

V-23-29 / 3951 Wieuca Road / Deferred

Applicant seeks 1) a special exception to place recreational sport court in yard adjacent to the public right of way and 2) a variance to reduce the east half-depth front yard from 25 feet to 19 feet.

U-23-7 / 3804 Roswell Road / Deferred

Applicant seeks a special use permits to operate four outdoor pickleball courts.
