Major Mitchell noted we are up 3% citywide, but down in violent crime. Four of the six zones are down overall, including Zone 2 (down -2% from this point this year). Zone 2 continues to face shoplifting (up 42%) and car break-ins (up 1%). Citizens should remove any valuables and guns from cars. APD is working with the city and other entities to improve homeless encampments.

Commissioner Al Wiggins noted there have been questions about the conversion from weekly to bi-weekly yard waste pick-ups. Mr. Wiggins said an outside company is doing a cost analysis for the curbside pick-ups, including solid waste, recycling and yard waste, which should be completed by year end. Yard waste pick-ups are challenging and difficult to predict due to the varying containers as well as difficulties with the waste transfer station; they have been unable to normalize the service or anticipate staffing needs. He noted once they have all of the findings and data in place, they will have a decision on reinstating a weekly pick-up.

A community member asked about weather-related pick-ups; Mr. Wiggins noted this would not be possible.

A community member asked about 2986 North Fulton with an illegally operating business; he noted this is a Zoning issue, not Code Enforcement.
