Major Vayens joined our meeting and was pleased to announce 2025 overall crime is down 30% in NPU-B and down for Zone 2 by 13% ytd. This is the 5th year in a row that Zone 2 has had decreases.

There were 429 stolen firearms so far this year with 76 stolen in Zone 2. Encourage everyone to be vigilant and follow recommendations of the Clean Car Campaign.

It was shared with the Major Vayens by Ms. Bliwise on behalf of a citizen, Mr. Coppola, that at the Publix at the Peach there has been aggressive solicitation and harassment that is bordering of shoppers. Groups of people requesting money. Mr. Coppola shared that he has contacted 311 in the past. It is intermittent Major Vayens recommended for citizens call 911. There is a 2nd group at Tower Place have been harassing people too. Major Vayens will share this with the Zone 2 team.

Ms. Bliwise congratulated Major Vayens on the opening of the Public Safety Training Center and that he should let us know if we can do anything to help them.

Ms. Starling shared that the 5k on May 3rd had been a big success. She shared information on an Atlanta Cycling fest on May 24th at 9am ride at Path 400.

Ms. Starling confirmed that there had been stop work orders recently in Buckhead. The bank at 3465 Lenox Road/Buckhead Loop that was transitioning to a Jared Jewelers was torn down and it was not supposed to be. Also, Starbucks on Piedmont across from Tower Place was torn down in error.

Shoppes around Lenox is getting a new vendor and the Krystal on Piedmont is becoming a Raising Cains.

They are working with the Parks department to transition the design documents to construction documents for Lordins Park and Mountain Way Commons. This will take a few months and then start the grant request process.

They offer an Officer housing subsidy of \$650/month to support officers which support them living in the community.

An Ordinance to adopt the Trails ATL Plan as the City of Atlanta's Master Plan for a citywide network of trails; to incorporate the Trails ATL Plan into the City of Atlanta Comprehensive Development Plan.

Mr. Ganther presented about the 30-year plan and shared the multiple waves of outreach.

Outreach included the following rounds of public outreach with has been going on for the approximately the last year and 3 months.

Funding is still to be determined.

Round 1 of outreach followed Plan A and went to NPU's. Then, there was a survey. The survey had 2500 respondents. This identified the destinations of the trails and the trail types. There will be street trails and greenways.

Round 2 of outreach went to Council Districts presented a draft map.

Round 3 of outreach went to Council Districts grouped together.

Round 4 this is the current round

The street trails will not lead to condemnation.

The greenways will respect private property but could impact the public right of way which could impact landowners.

Street trails (no condemnation) and greenways (not impacting private property) – is this right of way

Robert Patterson shared about the experience of the North Buckhead Civic Association (NBCA) for the Wieuca trail in North Buckhead. The Wieuca Trail is from NBCA 2015 Master Plan. Approved by neighbor and adopted by the City in 2015.

NBCA had a study done to take this trail and turns it into a side path.

This plan was adopted into the Trails ATL plan.

Mr. Ganther did share that there is some impacted private land as the path goes over Roswell Rd to Chastain Park.

Ms. Shorter was very concerned that other communities don't have the same bottoms-up planning as North Buckhead. How can we ensure the North Buckhead experience is what all our communities have.

Ms. Dobson and other attendees voiced concern about loss of trees. Mr. Gunther shared that they want to preserve trees. Ms. Dobson shared that in Peachtree Hills Park that they have seen trees lost due to these projects. Mr. Gunther shared that he is concerned that Trails ATL is being linked to other development that took trees.

There is concern about paths that create a shared space with scooters/bikes and walkers. This causes risk for walkers. There is a desire to better understand how this can be addressed.

Ms. Buckner from Parks & Rec stressed that the communities will be engaged in this process. She shared she understands concern that NPU-B would like more information in writing before we are asked to vote on it.

Ms. Bliwise asked if we are being asked to approve the plan and its approval for inclusion into the CDP. Mr. Gunther confirmed that this would be a vote approve the trails as they are defined at this time.

Mr. Patterson expressed concern this could impact the Wieuca Trail and all the work they have done. He may plan to do a presentation for the NPU at a future meeting.

Ms. Bliwise shared this mirrors the experience with the Peachtree Greenway. That impacted landowners/homeowners in ways they did not expect.
